



2021 Wildfowl Carving Championships

60/40 Auction Divisions

The 2021 Wildfowl Carving Championship 60/40 Auction Divisions require the carver be a US resident, due to the high cost of shipping and insurance outside the US. The competitor agrees to donate their entry, for auction on the Wildfowl Carving Championships platform. Photos and descriptions used for your entry in the Auction Divisions will be used as the auction photos. Be sure and add good Entry Titles and descriptions for your photos for the best results.

60% of the closing auction price will be paid to the carver, and 40% will be retained by Wildfowl Carving Championships.

Carvers will be expected to have their entries in the auction divisions, ready to ship to the buyer as soon as the auction ends.

Escrow.com will be used complete the transaction. This means, when the auction ends, the buyer sends their payment to Escrow.com. Escrow.com notifies you the funds have been received, at which time, you ship the package to the buyer. The buyer receives the package and has 48 hours to inspect their purchase. If satisfied, the buyer notifies Escrow.com and the funds are released to you. Transaction limitation is \$5000, therefore enter appropriately. If your entry is valued at more than \$5000, we won't be able to sell it auction. Therefore, enter accordingly.

The 60/40 Auction divisions, Decorative Head, Decorative Feather, Palm Frond, Cocktail Bird, and Decorative Pin, purposely small to make items affordable, and easy to ship safely and inexpensively. There will be a flat fee of \$25 charged for shipping of any sold auction item. You will be required to use the United States Postal Service (USPS) to ship your item Priority Mail in a free, USPS provided Flat Rate Box. They come in five sizes. Therefore, it will be important to keep your entry small enough to be packed sufficiently and shipped in one of these USPS Priority Mail Flat Rate boxes as listed below.

Priority Mail 2-Day™ Large Flat Rate Box – 2 Sizes
USPS-Produced Box: 23-11/16" x 11-3/4" x 3" or 12" x 12" x 5-1/2"

Priority Mail 2-Day™ Medium Flat Rate Box – 2 Sizes
USPS-Produced Box: 13-5/8" x 11-7/8" x 3-3/8" or 11" x 8-1/2" x 5-1/2"

Priority Mail 2-Day™ Small Flat Rate Box – 1 Size
USPS-Produced Box: 8-5/8" x 5-3/8" x 1-5/8"

APO/FPO/DPO Flat Rate Box 12" x 12" x 5-1/2" Inside 12-1/4" x 12-1/4" x 6" Outside

Seller will pay the flat USPS shipping fee and insurance equal to the final auction price of the item sold. The seller will receive \$25 flat fee paid by the buyer for shipping and insurance as reimbursement, with the 60% of the selling price in a final payment (less any Escrow.com fees, not paid by the buyer). The size of the selected USPS Priority Flat Rate Box will determine the flat rate cost of shipping within the US, (it will be less than the \$25 received from buyer). When you're your item has been shipped you will provide the tracking number to Escrow.com and to Wildfowl Carving Championships.

List of US Possessions, Territories, and Freely Associated States that are considered domestic for flat rate fees using USPS Priority Mail Flat Rate Boxes. In other words, if a competitor or buyer lives in any US State, US Possessions, Territories or Freely Associated States, they will be eligible for competing in the Auction Divisions, and eligible to bid on the Auction items.

60/40 Auction Division Competitor Agreement

1. I am a US Resident, living in the United States of America or US Possession or Territory.
2. My entry into the 60/40 Auction Division is a donation for auction, and I will receive 60% of the selling price, and Wildfowl Carving Championships retains 40% of the selling price.
3. If my entry was not carved by me, I will declare I am not the carver, and declare the name the carver, if known, in the Entry Title and Entry Description.
4. I agree to use Escrow.com to complete the transaction.
5. I agree to ship my donation to the address provided by the buyer within USPS Domestic Mailing locations, using the free USPS Priority Mail Flat Rate Boxes.
6. I will pay the flat rate shipping fee and cost of insuring the item for the selling price at auction.
7. I had been informed there will be no item sold at auction for less than \$100 and no more than \$5000 and will enter my donations accordingly.
8. I agree to package my item to safely and securely fit into one of the USPS Priority Flat Rate boxes, provided for free for USPS.
9. I will not hold Wildfowl Carving Championships, or Virtual Championships responsible beyond providing the auction platform to facilitate the sale of the donated entry, between the entrant (seller) and the buyer.
